



Page 1: This is the description of the right of way and the signature page. The Borough Council/Township Supervisor must sign on the lines below the property owner section, the secretary signs on the witness side.

Page 2: Is the Acknowledgement page to be completed by the notary. All Borough Council Members/Township supervisor that sign must be noted on the Acknowledgement. The solicitor also signs on the line indicated. Please also place the borough seal on this page where indicated.

Page 3-4: Exhibit "A" is a sketch of the locations of our facilities, no action needed.

Page 5: Titled Exhibit "B: is for the Pennsylvania Public Utility Commission, no action is needed on this page.

Page 6: The Resolution is to be signed by the Borough Secretary/Township Supervisor. This resolution can be replaced with your own if you wish.

Page 7: Certification for the Public Utility Commission needs to be signed and dated by the Borough Secretary.

Page 8: Acceptance page is for Verizon to sign once the document is completed by you; no action needed.
