

RESOLUTION 2021-11

**A RESOLUTION AUTHORIZING THE COUNTY OF DAUPHIN, PENNSYLVANIA TO
AWARD THE CONSTRUCTION CONTRACT UNDER THE
INTERMUNICIPAL COST SHARING AGREEMENT BETWEEN LONDONDERRY TOWNSHIP
AND DAUPHIN COUNTY FOR THE DAUPHIN COUNTY BRIDGE BUNDLING PROGRAM**

WHEREAS, Londonderry Township (“Municipality”) has entered into a Cost Sharing Agreement (the “Agreement”), dated July 1, 2019, with the County of Dauphin (the “County”), a third class county of the Commonwealth of Pennsylvania, with a principal office at Dauphin County Administration Building, 2 South Second Street, 4th Floor, Harrisburg, Pennsylvania 17101, to participate in the Dauphin County Bridge Bundling Program (the “Project,” which is more fully described in the Agreement); and

WHEREAS, as a part of the Project, repairs and improvements are to be made to bridge LDT-2, which is owned by and located in Londonderry Township; and

WHEREAS, consistent with Paragraph 3 of the Agreement, the County has bid the Project consistent with all procurement laws and regulations applicable to the County; and

WHEREAS, Kinsley Construction, Inc. (the “Contractor”) submitted the lowest qualified bid to complete the necessary construction work on bridge LDT-2, and

WHEREAS, the Contractor’s bid to complete the necessary work on bridge LDT-2 came in at \$ 610,531.75, which amount the Municipality has previously approved by execution of a Dauphin County Bridge Bundling Program Municipal Actual Cost Approval form; and

WHEREAS, pursuant to Paragraph 4(d) of the Agreement, the County may not award the construction contract without prior approval, by Resolution, from each of the participating; and

WHEREAS, Municipality desires to approve the award of the construction contract for bridge LDT-2 to Kinsley Construction, Inc., which contractor was the lowest qualified bidder; and

WHEREAS, Municipality further desires to authorize Steve Letavic, Township Manager to approve written change orders submitted by Contractor that the County also approves so long as such change orders do not collectively result in a total construction cost that exceeds the budgeted costs set forth in Exhibit A of the Agreement.

**NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE BOARD OF
SUPERVISORS OF LONDONDERRY TOWNSHIP, DAUPHIN COUNTY, PENNSYLVANIA

The Dauphin County Commissioners are authorized to provide written award of a construction contract consistent with paragraph 4(d) of the Intermunicipal Cost Sharing Agreement awarding the

construction contract for the necessary improvements and repairs to bridge LDT-2 to Kinsley Construction, Inc. in the amount of \$ 610,531.75.

IT IS HEREBY FURTHER RESOLVED BY THE BOARD OF SUPERVISORS OF LONDONDERRY TOWNSHIP, DAUPHIN COUNTY, PENNSYLVANIA THAT:

Steve Letavic, Township Manager is authorized to approve written change orders submitted by Contractor that the County also approves so long as such change orders do not collectively result in a total construction cost that exceeds the budgeted costs set forth in Exhibit A of the Agreement.
