An Executive Session took place prior to the meeting to discuss personnel matters. No action was taken.

Approval of Minutes

Chairman Geyer requested a motion to approve the April 6, 2026, Regular Board of Supervisors Meeting Minutes.

It was moved by Mr. Shellenhamer and seconded by Ms. Dale that the Board approves April 6, 2026, Regular Board of Supervisors Meeting Minutes. The motion carried unanimously.

Manager's Report – David Blechertas

- Presentation and update from Harrisburg Rugby Club

Andy Vazquez, President of the club provided the Board with a presentation regarding Perseverance Lodge Fields at Sunset Park. His presentation included history of the Club, Board of Directors of the club and a timeline of what has been done to the field since 2018. He said the club is working on being in compliance with the Dauphin County Conservation District. Over the last several months the club has removed vegetation overgrowth from basin and channel areas, re-seeded to eliminate bare spots and is continuing to maintain the fields.

- Request approval of Resolution 2026-18 in support of America250PA

It was moved by Ms. Dale and seconded by Mr. Kopp to approve the request above as stated. The motion carried unanimously.

- Request approval for a free pavilion rental for Geyers United Methodist Church.

It was moved by Mr. Shellenhamer and seconded by Mr. Merchlinski to approve the request above as stated. The motion carried unanimously.

- Request to amend the agenda due to a sudden need to take action.

It was moved by Mr. Shellenhamer and seconded by Ms. Dale to amend the agenda. The motion carried unanimously.

- Request approval to hire Tyler Christian as a full-time employee at the Sunset Golf Course at a salary of \$52,000 effective as soon as possible.

Mr. Blechertas stated the full cost of his salary and benefits are paid by the golf course and not the Township. The golf course is fully self-sufficient.

It was moved by Mr. Shellenhamer and seconded by Mr. Merchlinski to approve the request above as stated. The motion carried unanimously.
