A RESOLUTION ESTABLISHING A FEE SCHEDULE SETTING FORTH MISCELLANEOUS FEES FOR SERVICES OF THE TOWNSHIP OF LONDONDERRY EFFECTIVE JANUARY 1, 2026

WHEREAS, the Board of Supervisors of Londonderry Township, Dauphin County, Pennsylvania, wishes to continue its efforts to establish sound fiscal policies and fees for the Township of Londonderry; and

WHEREAS, the Board of Supervisors wishes to update its fee schedule to set forth the various miscellaneous fees for services provided by the Township effective January 1, 2026, in replacement of all provisions of the current fee schedule for the Township.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Supervisors of the Township of Londonderry, Dauphin County, Pennsylvania, that the fee schedule shall be amended, effective January 1, 2026, as follows:

Section 1.

<u>Miscellaneous Fees</u>. The schedule of miscellaneous fees of the Township, other than (a) for fees for services of the Township's Municipal Engineer, Herbert, Rowland & Grubic, and (b) fees of the Township's Sewage Enforcement Officer, Hanover Engineering Associates, Inc., attached hereto as "Exhibit A" and incorporated herein by reference, is hereby adopted, effective January 1, 2026.

Section 2.

<u>Municipal Engineer Fees</u>. The schedule of fees for services of the Municipal Engineer, Herbert, Rowland & Grubic, attached hereto as "Exhibit B" and incorporated herein by reference, is hereby adopted, effective January 1, 2026.

Section 3.

<u>Sewage Enforcement Officer</u>. The schedule of Sewage Enforcement Officer service fees as set forth in the schedule of Hanover Engineering Associates, Inc., attached hereto as "Exhibit C" and incorporated herein by reference, is hereby adopted, effective January 1, 2026.

Section 4.

The said schedules attached hereto as Exhibit A, Exhibit B and Exhibit C shall hereafter be collectively referred to as the "Londonderry Township Fee Schedule."

Section 5.

<u>Savings Clause</u>. If any section, subsection, paragraph, sentence or phrase of this Resolution, or any exhibit incorporated herein, or portion thereof, is for any reason held to be invalid by a Court of competent jurisdiction, such holding shall not affect the validity of the remaining portions of the Resolution, it being the intent of the Board of Supervisors that the same would have been enacted without such section, subsection, paragraph, sentence or phrase, or portion of exhibit. In the event of such holding, the Resolution shall be considered as effective as if enacted without such section, subsection, paragraph, sentence or phrase, or portion of exhibits.

Repealer. Any resolution, or part thereof, conflicting with the provisions of this Resolution is hereby repealed insofar as it conflicts with this Resolution.
