1) Mr. Letavic presented to the Board a request for approval of the Engagement Letter dated March 17, 2020 with Eckert Seamans for the Penn Vest Preconstruction loan.

2) Mr. Letavic presented to the Board a request for approval to enact the Ordinance 2020-02 as prepared by Eckert Seamans for the Penn Vest Preconstruction Loan.

Call for Discussion: Mr. Letavic stated Ordinance 2020-02 is a requirement of Penn Vest to ensure they are paid back. The low interest loan will be the interim line of financing. The general obligation amount is \$283,700 at one percent interest. The Township also received a grant in the amount of \$108,300 toward the project. Total cost is \$392,000.

Further discussion was made amongst the Board about the process with the assurance that Penn Vest would refund the money once the project has begun.

Mr. Letavic stated employees are limited to only accessing the drives needed in order for them to perform their specific duties. Omega is the Township's IT service, and they have very robust firewalls and security measures. Mr. Letavic further stated the Township has insurance. They dovetail the approach with Omega's security and the insurance company which protects and helps with recovery and legal action. Every year Mr. Letavic meets and reviews the services with Omega and the insurance company. Mr. Letavic stated the Township has a backup in the cloud and continually run the backup every day because they are proactive and not reactive. This year the entire server will be revamped along with new computer systems.

Board Chair, Mike Geyer, offered his appreciation for all the hard work, time and effort that Mr. Letavic has made during this time.

Mr. Letavic shared his appreciation with the help of the team and having the Board's leadership which allows the Township to do their jobs.

The Londonderry Township Fire Company has postponed the Fish Fry for two weeks and will resume April 3rd. They may extend the meals for two weeks.

Mr. Letavic understands the needs of the Fire Company and offered assistance moving forward with this situation.
