NO TAX INCREASE FOR 2018!

Londonderry Township Board of Supervisors adopted the 2018 budget on December 19, 2017. The budget as adopted, does not include a property tax increase. The Board worked hard to balance the needs of the Township with revenue available.

In adopting its 2018 budget the Board of Supervisors was able to hold the line on property taxes despite all the costs and challenges the Township faced from Right to Know Law abuse.

UPDATE ON ISLAND ENFORCEMENT & RELATED ISSUES

The Township continues to move forward with its floodplain enforcement plan as required by the Federal Emergency Management Agency. As previously reported, in 2017, the Township completed a compliance assessment of all recreational properties on Hill, Beech and Poplar Islands, and Bares Tip of Shelley Island, which are located in a regulated floodplain within the Township.

After completing the assessment, the Township began sending out informal, preenforcement notices to the approximately 200 owners of recreational cabins and homes on the Islands. The notices listed potential violations and invited owners to voluntarily provide information that the Township should consider in making its enforcement determination. These notices were sent no matter how big or small the suspected violation so there would be no surprises to the owners when the Township begins its formal enforcement process.

A large majority of these pre-enforcement notices have now been sent. The Township has received a number of responses and is carefully evaluating the information received. Several owners have applied for permits to bring their properties into compliance, or have indicated that they will take steps to do so as soon as it is safe to access the Islands again in the Spring. For those properties where formal enforcement will be necessary, the Township will begin sending out final enforcement notices in the coming weeks.

Owners will again have an opportunity to address the alleged violations and will be given a period of time to bring their structures into compliance with the Ordinance requirements.

2018 Taxes & Deadlines from the Tax Office

County/Township Real Estate—Taxes were mailed February 1

If you have not received them please call my office at 717-944-2842. The discount period ends March 31. Payments must be in my office or postmarked by March 31 to receive the discount.

School Real Estate and School Personal— Taxes will be mailed July 1

You can take advantage of the three (3) payment plan on the school real estate tax only. The first payment must be made by August 31 to take advantage of the plan. There is an exoneration of the school occupation tax if you are over 70, a full time college student both semesters, earn under \$6000 (retirement and social security do not count toward the \$6000,) or are a member of the clergy with no other income.

This is for the occupation tax only. There is no exemption for the per capita (\$10) or the Township (\$5) tax.

Please Note:

An exemption form must be submitted to me if you were billed the \$250 occupation tax, and want to apply for the exemption. Forms are available at my office or can be downloaded at www.ldsd.org.

TAX TIP: Did You Buy a New Home?

Be sure to file a Homestead Exclusion form with Dauphin County Tax Assessment. This is money we get from the slot machines, to offset some of the school real estate tax. It does not affect the county/Township real estate tax.

Benefits of Nuclear Energy for the State of PA

Nuclear is critical to our state's energy mix, generating nearly 40% of the Commonwealth's electricity.

Nuclear provides affordable emission free power 24/7.

It produces 93% of PA carbon-free electricity from five plants. This amounts to 37 tons of carbon emissions. That is equivalent of keeping 10 million cars off the road per year. In absence of TMI, within PA alone, emissions of carbon would increase by 2 million metric tons annually.

PA is the fifth largest producer of carbon-free electricity.

PA's five nuclear plants operate energy 24/7 365 days. TMI alone, produces enough energy to serve 800,000 homes.

There is a \$2 billion approximate annual contribution from the nuclear plants in PA to our economy per a report from the Brattle Group.

The nuclear industry has approximately 16,000 full time jobs created by the nuclear plants. TMI has 675 local workers with an annual payroll of approximately \$60 million.

Just in PA the plants generate \$400 million in federal and state revenue.

More than \$300,000 is contributed to charities by TMI each year. Employee's generously donate to local organizations.

This is where we come in. The Londonderry Emergency Management has benefitted tremendously by TMI. Every year since 2004 we have submitted for the Radiation Emergency Response Funds (ACT 147) and received monetary funds to purchase many different items necessary to run our emergency operations center. This could not have been available without TMI in existence so we are very grateful and hope they can stay in operation.

These are just some of the benefits Pennsylvania and our local economy can contribute to the Nuclear Power Co.

IF YOU HAVE A PROPERTY ON THE ISLANDS ...

- A floodplain development permit must be obtained from the Township prior to construction of any kind; no matter how minor the project may seem.
- Restrictions exist on the types of building materials that can be utilized in the floodway.
- Demolition permits from the Township are also necessary if structures will be removed.

Permits for construction activity to raise cabins above the floodway elevation have recently been issued by the Township and more are in process. People are successfully coming into compliance with the Township's Floodplain Ordinance.

Throughout the enforcement process and after it is completed, owners will continue to be able to use their properties for recreation in ways that are permitted under the Flood Plain Ordinance. The Township does not have any plans for development of the Islands.

Any future development plans would have to be generated by the property owners subject to the requirements and any approval needed under the Township's Ordinances.

BESHORE ISLAND & NORTHERN PORTION OF SHELLEY ISLAND ONLY – IMPORTANT REMINDER:

The Township continues to monitor York Haven Power/Cube Hydro's compliance with its Compliance Agreement from April 2016.

By October 31, 2018 York Power will remove all structures from its properties. The Lot License Holder is obligated to remove any structures or materials and restore the recreational lot. Former seasonal renters should contact York Haven Power/Cube Hydro to coordinate removal or demolition activities.

COURT PROTECTS RESIDENT TAXPAYERS...

The Township has been forced to take action to protect the taxpayers from the tactics of one individual who has engaged in a persistent campaign to abuse the <u>Right to Know Law Process</u>. Over the past several months, Township staff has searched for, compiled and copied more than 7,500 pages of documents for this one individual. <u>Over those months, this individual has:</u>

- Made 108 requests for information
- Filed 81 appeals with the Pennsylvania Office of Open Records, many of which were filed even after Township staff searched for and produced documents to him
- Filed more appeals than are filed for every public agency in the city and county of Philadelphia (with a population of more than 1.6 million people) in an entire year
- Caused the Township to incur the cost of hiring a temporary employee to help process the tremendous number of requests and appeals
- Required staff to spend more than 65 hours per week doing nothing but searching for and reproducing documents and otherwise answering his requests and appeals
- Consumed more than 1,100 hours of Township employee time in total, keeping these employees from doing their normal jobs and Township business.

In addition to the personnel time, the Township has also had to incur substantial legal costs to address the volume of requests and appeals, and to raise objections to abusive and non-specific requests. Through mid-December, the State consistently ruled in favor of the Township. The Office of Open Records completely rejected 46 of the first 48 appeals filed by this individual, and partially denied the remaining two appeals.

But, despite the State's siding with the Township, the cost to the taxpayers and the draining of personnel resources from this abuse was too great. The Township had to take action. To reduce the staff burdens, the Township began challenging requests and appeals before the Office of Open Records based on their lack of good faith. The Township also asked for protection from the Dauphin County Court of Common Pleas. *On February 5, 2018, the Court granted that protection and ordered the individual in guestion to stop his conduct.*

Londonderry Township is an open government. It has always processed Right to Know Law requests with little effort and few objections. However, the Township cannot and will not stand by when it is clear that an individual is not filing legitimate requests and appeals, but instead is abusing the process as a means to retaliate against the Township. The public interest and the interests of the taxpayers demand as much.

Without relief from the Court, a very different result would have played out this year as the Township would have been forced to consider a tax increase on every Township property owner.

NOTEWORTHY ... by Kenworthy

TOWNSHIP INFRASTRUCTURE NOT A CONCERN

We regularly hear about the condition of infrastructure in the United States and many times the news is bad. Too often we hear about underground pipes breaking, roads crumbling, and bridges that need to be closed. Londonderry Township has its share of local infrastructure concerns. Fortunately for the local Township bridges, the infrastructure news is actually pretty good.

The upkeep of bridges can seem like a daunting and expensive task. However, successful upkeep is fairly simple. Consistent inspections to identify deterioration, regular maintenance to avoid

worsening problems and advanced planning for eventual replacement, all combine to simplify bridge upkeep and ensure it remains affordable.

Londonderry Township is specifically responsible for 13 bridges, all of which are less than 20 feet in length and cross waterways. The need to close any one of these bridges for safety concerns could mean a significant disruption to emergency access and general traffic flow. Therefore, in the Spring of 2009 the Township engaged Herbert, Rowland & Grubic engineers to conduct an assessment of all 13 structures and prioritize their maintenance and replacement needs. That evaluation indicated all bridges were likely over 50 years old and six of them should be replaced within the next three to ten years.

In order to avoid unexpected road closures and to be able to fund the bridge replacements without overburdening the Township's annuallyupdated five-year spending plan, an approach was established to address this pressing infrastructure need. The initial concept was to replace one bridge about every other year for the six most critical structures. This approach would allow alternative funding to be identified, major traffic interruptions to be minimized and have some of the most urgent Township needs addressed, without being an emergency situation.

What is the status of the Township bridges now? Two bridges were replaced in 2012. The first was on Round Top Road, as planned. Unfortunately, in 2011, flooding from Tropical Storm Lee undermined the bridge on Foxianna Road and it had to be replaced immediately. Fortunately, because of the emergency nature of that bridge replacement, the Township was able to utilize federal disaster relief funding for its replacement.



Three bridges were replaced in 2016; one each on Beagle, Braeburn and Hollandale Roads. This was achieved by bundling three bridges in separate areas of the Township into one project and utilizing extremely favorable funding provided by the Dauphin County Infrastructure Bank. And here in 2018, through the partial use of a Dauphin County Local Share Gaming Grant, a bridge on Swatara Creek Road will be replaced.

With the replacement of the six most critical bridge structures complete, the Township can now focus on regular maintenance of the remaining seven structures to extend their useful life as long as possible – a much more affordable effort than replacement, which averages about \$200,000. When it does come time to replace one of these structures, the Township will take the same judicial approach to ensure the infrastructure needs of the Township are met in an economical manner.

Storm pipes that are under private driveways are owned by the property owner, not the Township. Over time, sediment, leaves and debris build up in the pipe and at the pipe ends, preventing storm water from passing through. In most cases, the water travels around the pipes, usually onto the roadway causing a traffic hazard. In the Winter months. this water can freeze on the roadway, causing a major traffic hazard. It is the responsibility of the property owner to make sure these pipes are functioning properly by routinely checking and clearing the pipe and pipe ends. The Township requires a "Driveway Repair Permit" be acquired at a nominal fee for any repairs; other than normal maintenance, or replacement of these pipes before beginning work along a Township road.

As Winter ends and Spring arrives, there will be pot holes appearing on Township roads. The Township Road Crew performs weekly "Road Checks" of all Township roads. If you see a pot hole, you can report it to the Township office at 717-944-1803, or leave a message on the Township Public Works answering machine at 717-944-9440. Please be as specific as possible to the location. It is also helpful to give your name and phone number in case we cannot locate the pot hole.

We have many projects planned for this Spring and Summer. Please check the Township website and Facebook for upcoming projects. Scheduled road projects that involve closing a road will be posted at least 1 week in advance, with a detour posted. In some cases, an emergency road closure is required. We will post the road as soon as possible if this will happen.

During the Summer when grass is being mowed, please do not blow grass onto the roadway. This is a traffic hazard, and will also clog storm drains and gutters. If you do blow grass onto the roadway, please clean it off as soon as possible to avoid any hazards.

REMINDER: ON-LOT SEWAGE DISPOSAL SYSTEM INSPECTION PROGRAM (OLSDS) SEWER DISTRICTS NOS. 1 & 2 JUNE 1, 2018 - JUNE 30, 2019

Londonderry Township has been mandated by the Pennsylvania Department of Environmental Protection to establish an On-Lot Sewage Disposal System Inspection Program (OLSDS). Every OLSDS in the Township is required to be inspected and every treatment tank or cesspool associated

with every OLSDS shall be pumped and inspected at a minimum regular interval of once every four (4) years by a certified pumper/hauler.

Property owners within Sewer Districts Nos. 1 and 2 are once again required to have their on-lot sewage disposal systems pumped and inspected by a certified pumper/hauler **BEGINNING** on or after June 1, 2018 and completed **BEFORE** June 30, 2019.

Spring Cleaning for the Environment!

Longer days, rain showers, baseball, and cleaning are just a few things that come to mind when you think about Spring. And since we don't have much to say about game or weather predictions, we thought we would share some storm water-friendly Spring cleaning tips.

OUTDOOR CLEANING. Remember to always use a broom instead of a hose to remove litter from driveways or sidewalks. Sweep litter back into your yard or into your compost pile. This prevents debris from entering a nearby creek or river. Even grass clippings and excess leaves don't belong in our streams.

LAWN CARE CHEMICALS. Unfortunately, it is often the case that wind up washing right into local waters. There are some easy solutions to stop that from happening:

- Go natural! You may not even have to spend money on fertilizing your lawn Mow your grass high, about 3 inches, and leave clippings on the lawn
- If fertilization is necessary, September is the best month. Soil testing should be done before fertilizer application
- Remember to use less. This will also help save you money, too!
- Do not apply fertilizers or pesticides within 75 feet of waterways
- Don't apply fertilizers or pesticides when there is rain in the forecast
- Hand pick weeds when possible, and only spot treat rather than dousing the lawn

Try using our "WEED BE GONE" Recipe

- 1 gallon white vinegar
- 2 cups Epsom salt

• ¼ cup Dawn dish soap Spray weeds in morning after dew dries. Weeds will be gone by evening.

Are you planning to dispose of old paint or household cleaners?

PLEASE DON'T POUR THEM OUT! Instead, call Dauphin County's curbside household hazardous



waste program at 1-800-449-7587. This is a program available to each household for FREE, one time per year.

When poured on the ground or into an inlet, these toxins are carried by storm water directly into a nearby creek or stream. Untreated, they eventually end up in the Susquehanna River. **And who wants to swim or fish with paint?**

Chesapeake Bay Pollution Reduction Plan

As of September 2017, Londonderry Township has completed the next step in the restoration effort of local water bodies and the Chesapeake Bay. This comes in the form of the Chesapeake Bay Pollution Reduction Plan (CBPRP), a DEP mandated plan to meet the Total Maximum Daily Load (TMDL) requirements set by the federal government.

This plan sets a 5-year goal to reduce pollution into our local waterways by installing Best Management Practices (BMPs). The Township is required to reduce pollution caused from sediment by 10%, Phosphorus by 5%, and Nitrogen by 3%. It is assumed that by meeting the reduction in sediment pollution the phosphorus and nitrogen reductions will also be met, since these pollutants bind to soil particles. The current calculated sediment pollutant load (accounting for all previously installed BMPs) is 544,872 lbs/yr, meaning that the Township is responsible for reducing this by 54,487 lbs/yr.

In order to meet these reduction goals, the Township has developed a plan involving three projects for BMP implementation. The plans are preliminary and may change during the permit cycle if more feasible/cost effective projects are discovered. The current project list is made up of a stream restoration in the Conewago Creek (including 2 bioswales) and two detention basin retrofits. Between these three projects the calculated Load Reduction is 57,276 lbs/yr, slightly exceeding the required reduction for the 5-year permit.

Riparian Buffers

WHAT IS A RIPARIAN BUFFER?

Riparian Buffers are vegetated areas adjacent to waterways (e.g. streams, rivers, wetlands) that provide protection from pollution from human land use. They assist in keeping the waterway clean by filtering out sediments and nutrients, particularly nitrogen. Riparian Buffers also deter streambank erosion and provide areas for aquatic and wildlife habitat.

WHAT ARE THE BENEFITS OF BUFFERS?

- Trap, filter and slow runoff
- Stabilized streambanks
- Increase aesthetic value
- Reduced impacts from flooding
- Provide shade for temperature control
- Absorb and store excess nutrients
- Provide food, cover and habitat for wildlife

Tree Canopies

Although "tree canopies" are scenic and enjoyable to drive through, they can also cause



a hazard to vehicles and the road surface. While low hanging branches keep the road shaded, this also keeps the sun from drying the road after it rains and hinders the melting process of ice and snow in the Winter. Emergency vehicles have to travel slower, due to low hanging branches striking the vehicles. Trucks such as delivery vehicles, school buses and garbage trucks also have a difficult time passing safely under low hanging limbs. During rain and snow events, these limbs hang even lower than usual making passage even more difficult.

It is not our intent to remove all trees from hanging over the roadway, but we do have to make it safe for all vehicles and pedestrians to travel the roads. We will be removing limbs back 3'-4' from the edge of the pavement and 16' to 20' above the road surface. We will also be removing dead limbs that we can reach before they fall on vehicles or pedestrians.

Fees collected are used to underwrite costs of monitoring PA kennels and puppy mills as well as other dog welfare initiatives not funded by tax dollars. **Dog tags run with the calendar year and must be renewed annually!**
