## **PUBLIC NOTICE**

Notice is hereby given that on Tuesday, April 20, 2021 at 7:00 p.m., the Board of Supervisors of Londonderry Township, Dauphin County, Pennsylvania, will hold a public meeting at which meeting the Board will consider the enactment of a proposed ordinance amending the Code of Township Ordinances, Chapter 10 (Heath and Safety) to add Part 2 (Public Safety Radio Amplification Systems). The title and summary of the proposed ordinance is as follows:

## **ORDINANCE NO. 2021-06**

AN ORDINANCE TO AMEND THE CODE OF ORDINANCES OF THE TOWNSHIP OF LONDONDERRY, CHAPTER 10, HEALTH AND SAFETY, TO EXPRESSLY ESTABLISH IN PART 2 NEW REGULATIONS ON PUBLIC SAFETY RADIO AMPLIFICATION SYSTEMS; TO PROVIDE FOR THE SEVERABILITY OF THE PROVISIONS THEREOF; AND TO PROVIDE FOR THE EFFECTIVE DATE THEREOF.

In Section 1, the proposed amendatory Ordinance creates a new Part 2. Subpart 201 addresses the purpose of the Ordinance, which is to provide minimum standards to ensure reliability for emergency services communications from within certain new and modified larger-scale buildings including those with high concentrations of steel, machinery or concrete that interfere with communications between emergency responders. Subparts 202 and 203 of the Ordinance respectively provide definitions and address the applicability of the Ordinance. Subpart 204 addresses radio coverage and amplification system requirements. Subpart 205 addresses the qualifications of personnel designing, installing and testing radio systems, the testing procedures, and the proof of compliance owners are required to provide to the Township. Subpart 206 addresses violations and the penalties for violations of the Ordinance.

Section 2 of the Ordinance repeals all ordinances or parts thereof inconsistent with or in conflict with this Ordinance. Section 3 provides for severability in the event of invalidity. Section 4 provides for the Ordinance to take effect five days after its enactment.
