230 Corridor Sewer Development Update

There has been a lot happening in Londonderry Township relative to the DEP mandated installation of sewer in the Route 230 Corridor.

This sewer installation is part of the Township's official sewage management or 537 Plan and is a state requirement from the Department of Environmental Protection. The issue for the Township has been "how can we possibly afford this?". The project is expected to cost a total of \$26,000,000.00 and is simply not something the township could afford to implement on its own, we simply do not have the tax base to generate enough funding to do so. The lack of tax base also means that the Township could not borrow its way to a funding solution.

The answer was to find partners in the construction of the sewer lines and create a tax base for future expenses. The township was able to partner with two developers to fund \$15,000,000.00 of the cost to design, permit and construct the line. The developer's contributions will fund the cost of the line (and pump stations) from the Derry Township Municipal Authority's southwest plant (located on Swatara Creek Road) along the Route 230 corridor to its furthest point located at Hoffer Road. There will be capacity in the main line for the Township to add connections and in this way help us along the path to compliance with DEP while saving our residents \$15,000,000.00!

We will still have to find a way to fund the additional requirements in the 537 plan, and that is where the tax base will help. The township will receive real estate taxes from the developments once they are completed and we can use this revenue to help offset some of the cost of meeting our mandated 537 plan compliance. The two developers will build three logistics centers that are expected to create almost 1,500 jobs in Londonderry Township! The employees that work at these centers will patronize our local businesses further spurring the local economy. We believe that the preliminary sewer line design will be completed this spring and that final design and permitting will be completed in the fall of this year. The township anticipates bidding, award and construction of the lines and pump stations to begin in the beginning of 2021, with construction completed by the first quarter of 2022. Construction of the logistics centers may occur simultaneously with the construction of the sewer lines, however, the timing of that construction will be at the developer's discretion. While this project meets the immediate needs of the 537 plan the intent is to limit this development to the Route 230 Corridor and to preserve the rural nature of the township.

This is a major undertaking and the first time we have done it, so please be patient with us as we work our way through the process. Please feel free to reach out to the Township at 717-944-1803 if you have any questions on these projects.

Summer Maintenance

Storm pipes that are underneath private driveways are owned by the property owner, not the Township. Over time, sediment, leaves and debris build up in the pipe and at the pipe ends, preventing storm water from passing through. In most cases, the water travels around the pipes, usually onto the roadway. In the winter months, this water can freeze on the roadway, causing a major traffic hazard. It is the responsibility of the property owner, not the Township, to make sure these pipes are functioning properly by routinely checking and clearing the pipes and pipe ends.

As winter ends and spring arrives, there will be potholes appearing on Township roads. The Township Road Crew performs weekly "Road Checks" of all Township roads. If you see a pothole, you can report it to the Township office at 717-944-1803, or leave a message on the Township Public Works answering machine at 717-944-9440. Please be as specific as possible to the location. It is also helpful to give your name and phone number in the event we cannot locate the pothole. Thank you.

We have many projects planned for this spring and summer. Please check the Township website and Facebook for upcoming projects. Scheduled road projects that involve closing a road will be posted at least one week in advance, with a detour posted. In some cases, an emergency road closure is required. In the event of an emergency, we will post the road closure as soon as possible.

During the summer when grass is being mowed, please do not blow grass onto the roadway. This is a traffic hazard, and will also clog storm drains and gutters. If you do blow grass onto the roadway, please clean it off as soon as possible.

Winter is over, but this summer will be a good time to examine the condition of your mailbox and post. Most mailboxes are located within the Township right of way. When clearing a heavy, wet snow from roads, unfortunately, mailboxes do get damaged. One idea is to mount your mailbox on a swivel, so if the plow truck hits the mailbox, it will swing around, which may prevent it from being damaged.






Spotted Lanternfly–Help Locate Them

Riparian Buffers

Do you have an eroded bank on your property? Is your property line receding because it is falling into the creek? Creeks, streams and rivers will stabilize when they are planted with grasses and trees, these areas are called Riparian Buffers. A riparian area will not only prevent erosion, but will filter pollution from human land use before it reaches the water.

Benefits of Buffers

- Prevent stream bank erosion by using roots for stabilization
- Reduced impacts from flooding
- Increase aesthetic value
- Trap, filter and slow runoff
- Provide shade for temperature control
- Provide food, cover and habitat for wildlife
- Absorb and store excess nutrients which are associated with decreased water quality

Tree Canopies

Although tree canopies are scenic and enjoyable to drive through, they can also cause a hazard to vehicles and the road

surface. While low hanging branches keep the road shaded, they also keep the sun from drying the road after it rains, and hinders the melting process of ice and snow in the winter. Emergency vehicles must travel slower to avoid low hanging branches from striking their vehicles. Delivery trucks, garbage trucks, and school buses also have a difficult time passing safely under low hanging limbs. During rain and snow events, these limbs hang even lower than usual making safe passage more difficult.

It is not our intent to remove all trees from hanging over the roadway. But we do have to make it safe for all vehicles and pedestrians to travel the roadways. We will be removing limbs back 3 to 4 feet from the edge of the pavement, and 16 to 20 feet above the road surface. We will also be removing the dead limbs that we can reach before they cause damage to vehicles or pedestrians.

Grass on the Roads

When mowing your grass this summer, make sure to keep all grass clippings and garden



trimmings off of the road.

When left on our roads, they can create dangerous driving conditions, especially for motorcyclists, as well as add to stormwater runoff. This debris, often times containing fertilizer, is not meant to be in our waterways and disrupts the natural ecosystem. Please make sure to either blow or sweep your clippings from the road, do not dump them down the storm sewer. It's also a good idea to leave the grass clippings on your lawn. They serve as a great natural fertilizer!

LONDONDERRY TOWNSHIP ILLICIT DISCHARGE AWARENESS

An illicit discharge is any discharge not composed entirely of stormwater, entering a Municipal Separate Storm Sewer System aka an "MS4" aka a storm drain.

An illicit discharge also includes any piping or drainage leading directly into a storm drain that was not initially placed during construction. MS4's are only intended to carry stormwater directly to streams and rivers. Any illicit discharges flowing into an MS4 can pollute the streams in the area, harming the wildlife and way of life of the people who use these streams.

How You Can Help?

The easiest way you can help is by disposing of liquid wastes properly and not allowing them to flow into storm drains. You can also check your storm drains near your home to make sure no pipes are flowing from your home which you were not previously aware of.

If you notice a possible illicit discharge you can contact the MS4 Environmental Specialist at 717-461-0027.

However, if you ever see a rare, large quantity spill which would be unable to be handled locally, please call DEP's South-Central 24/7 Emergency number at 866-825-0208.

Examples of Illicit Discharges

- Sanitary Wastewater
- Septic Tank Effluent
- Chlorinated Pool Discharge
- Improper Oil/Radiator Flushing Disposal
- Laundry Wastewaters
- Spills from roadway accidents
- Improper disposal of household toxins

Exemptions

- Discharges from fire-fighting activities
- Fire hydrant flushing
- Potable water, including water line flushing
- Uncontaminated condensate from air conditioners, coolers, and other compressors and from the outside storage of refrigerated gases or liquids
- Irrigation drainage
- Landscape watering provided all pesticides, herbicides, and fertilizer have been applied in accordance with the approved labeling
- Pavement wash waters where no detergents are used and no spills or leaks of toxic or hazardous materials have occurred
- Routine external building washdown that does not use detergents
- Uncontaminated ground water or spring water

Common Spill/Illicit Discharge

Rare, large quantity spill unable to be handled locally

EMERGENCY – Immediate danger to health, property, and environment

Invasive Plants & Animals

Invasive plants and animals are nonnative to the area they are residing, and outcompete the native plants and animals. Invasive plants typically have natural advantages such as distributing large numbers of seeds, aggressive root systems, and/or produce leaves earlier in the season than their native counterparts, allowing them to sprawl out, blocking light from reaching the native plants. Similarly, nonnative plants do not provide necessary nutrients, and typically have an unpleasant taste to our native animals therefore, nonnative plants do not get grazed down at the same rate a native plant would. This allows the nonnative invasive species to grow uninhibited, and puts greater pressure on the remaining native plants.

TREE OF HEAVEN (AILANTHUS)



- Can grow from 80-100 feet tall and 6 feet in diameter.
- Leaves are attached along a central stem, positioned directly opposite of one another. Each stem can hold between 10-40 leaflets spanning 1-4 feet long.
- Pointy, riveted leaves, blossoms with yellowish flowers above the leaves.
- Leaves smell like cat urine or burnt peanut butter when crushed.
- Almost identical to Sumac.

Do not pull, as the root system will reinforce itself, and will sprout twice as strong the next season. To learn more about the treatment of the Tree of Heaven, contact MDykman@londonderrypa.org, or refer to documents published by Penn State Extension, or another creditable source.

Special Threat

- Grows everywhere and anywhere. Will even grow in between cracks in the sidewalk. Tree roots are extensive. May damage building foundations, underground pipes, and even kill other plant species nearby.
- Known as the host tree for the spotted lantern fly.

POISON HEMLOCK



- Located along roadsides, field margins, ditches and waste areas.
- Hollow, purple stem reaching up to 8 feet tall. Leaves are "dissected", or intricately cut similar to a fern.
- Smells like parsnip when crushed.
- As the name suggests, ingesting poison hemlock is toxic for wildlife and humans even years after removal.

Luckily, removal of the entire root system is unnecessary to eliminate poison hemlock.

Poison hemlock can be controlled by hand pulling, or using Roundup. Roundup is often the preferred method to hand pulling to prevent an adverse reaction of painful blisters resulting from poison hemlock coming in contact with skin, then being exposed to sunlight.

GARLIC MUSTARD



- Located in moist, shady areas, especially next to riverfronts.
- Triangular heart shaped leaves that smell garlicky when crushed.
- Blooms clusters of white flowers.
- Leaves will remain green through winter

To remove, one must be persistent, as the seeds can remain in the soil for 5 years, or more. Hand pull plants as roots are not extensive and come up easily. All materials should be removed from the site to prevent regrowth.

JAPANESE HONEY SUCKLE



- This shade intolerant plant is located in a variety of habitats including: forests, wetlands, farm fence rows and roadsides.
- This woody vine can grow up to 80 feet in length, with oval shaped leaves.
- Nonnative/invasive honey suckle will grow in moist soil, whereas the native shrub will prefer dry and rocky soils.
- The plants are best known for their fragrant white and yellow flowers, which bloom between April and July.

To remove, apply herbicide to a cut stump. Repeated control, monitoring and sprout removal may be necessary. Hand pulling and mowing are not suggested as the root system can produce denser sprouts.


Spring Cleaning

Longer days, rain showers, baseball, and cleaning are just a few things that come to mind when you think about spring. And since we don't have much to say about game or weather predictions, we thought we would share some stormwater-friendly spring cleaning tips.

When you clean the outside of your house and do yardwork, remember to always use a broom to remove litter from driveways or sidewalks - instead of a hose. This will prevent debris from entering nearby creeks or rivers. Instead, sweep litter back into your yard or into your compost pile – especially grass clippings and leaves!

THINKING ABOUT CLEANING UP YOUR LAWN CARE ROUTINE?

Lawn care chemicals often end up washing right into local waters – wasting your money and polluting our streams and rivers! Try these methods to save green – and be green!



What is grasscycling? Recycling grass. Mow your grass high, about 3 inches, and then leave the clippings on your lawn. Cut frequently to promote the smaller clippings settling into the soil, and prevent longer grass unable to settle down, which can end up looking like hay.

If fertilization is necessary, September is the best month to apply it. Don't apply fertilizers or pesticides when there is rain in the forecast, and never apply fertilizers or pesticides within 75 feet of waterways. Using less fertilizer will save you money, as well!

"WEED BE GONE" Recipe

YEAH, EVERY

TIME IT RAINS,

- 1 gallon white vinegar
- 2 cups Epsom salt
- ¼ cup Blue Dawn dish soap

Spray weeds in morning after dew dries. Weeds will be gone by evening.

Hand pick weeds when possible, and only spot treat rather than dousing the lawn. Try using our "Weed Be Gone" recipe above.

Are you planning on disposing of old paint or household cleaners? Please don't pour them out! Instead, call Dauphin County's curbside household hazardous waste program at 1-800-449-7587. This is a program available to each household for FREE, one time per year. When poured on the ground or into an inlet, these toxins are carried by stormwater directly into a nearby creek or stream, untreated, which eventually end up in the Susquehanna River. And who wants to swim or fish with paint?

Londonderry Estates Sewer Project

Londonderry Township has been working with residents over the past year to construct sewer in the Londonderry Estates development. This is a requirement of the Township's Official Sewage Management plan that is mandated by the Department of Environmental Protection.

The Township was recently awarded a combination of grants and loans by PA Vest which is the state agency that provides some funding for these types of projects. The Township received \$108,300.00 in grants and \$283,700.00 in loans from PA Vest. These initial funds are to be used to complete the design and permitting for this project. We expect that process to be completed in December of 2020. When we receive approval from DEP on the design and permitting we will use this information to determine the cost of construction of the lines. The township will use that cost estimate to submit another PA Vest application for the construction of the lines. That application is anticipated to be submitted in winter/spring of 2021. Based upon the results of that PA Vest application (funding received) we anticipate construction on the lines to begin in the spring/summer of 2021, and connections to the line to be completed in the summer/ fall of 2022.

Additionally the township has applied for an H2O grant from the Commonwealth Financing Authority for \$985,000.00 to offset some of the cost of the project which is expected to be approximately \$1,900,000.00. We expect to hear the results of that grant application in May of this year. The Township is exploring every opportunity to obtain funding for these projects and reduce the cost to our residents. This is the first sewer project that the Township has undertaken so please be patient with us as we work our way through the learning curve. Conewago Creek Restoration Project Update

The Conewago Creek Restoration
Project is on track to meet the
mandated, and unfunded, Pollution
Reduction Plan (PRP) - as part of the
Municipal Separate Storm Sewer
System (MS4) permit. Right now, the
health of the creek is in danger. Erosion
is causing farmers along the creek to
lose valuable soil, and unmanaged
stormwater runoff is carrying
pollutants into the creek – threatening



the water quality, that both humans and animals depend on.

Unlike municipalities, water has no borders. The Conewago Creek watershed encompasses many municipalities before discharging into the Susquehanna River, which provides drinking water to millions of Pennsylvanians. The river then feeds into the Chesapeake Bay, our nation's largest estuary. Restoring the Creek will have immense benefits including improved downstream water supplies, improved recreation in Londonderry Township, reduced flood potential, and reduced sediment and nutrient pollution, while consequently improving water quality.

In order to avoid spending tax payer money, the Township has pursued and secured funding from numerous sources. National Fish & Wildlife Foundation (NFWF) provided nearly \$50,000 to study the creek, identify the causes of pollution and determine priority areas to restore. This winter, the NFWF grant was completed and interested residents can find the case study at www.Londonderrypa.org > Stormwater Management & MS4 > CBPRP. This initial study identified three individual project sections for stream restoration, which will be completed as funding is available.

In total to date, the Township has received more than \$1.3 million in funding to cover the cost of a project that will include stream restoration measures such as streambank stabilization, removal of legacy sediment and floodplain reconnection. Additionally, this funding covers the construction of three (3) bioswales that will be built on farmland alongside the creek. Pennsylvania Department of Environmental Protection (PADEP) is providing nearly \$200,000 from the Sunoco Pipeline settlement to fund the design and permitting of measures identified in the initial study. PADEP is also providing two (2) grants from its Growing Greener program to fund the construction of these measures once design and permitting are complete. More recently, the Township applied to the Commonwealth Financing Authority for additional funding to cover the cost

of riparian buffer plantings. Forested riparian buffers are vital to stream restoration, improving water quality and aquatic habitat, by stabilizing the streambanks and providing shade to reduce water temperatures.

They will be pursuing engineering solutions from Herbert, Rowland & Grubic, Inc. (Township Engineer) and Land Studies, Inc. that will improve water quality in the most

cost-effective ways. Mt. Joy Township, our neighbor on the south side of the creek, will be contributing funding in support of these efforts because they too will benefit from improved water quality in Conewago Creek and will also be using the Conewago Creek Restoration to fulfill their PRP requirements. The NFWF case study highlights the economies of scale and cost savings to each municipality. This is a significant effort that has involved many partners to date. This is why a wide variety of public and private organizations have joined together in the effort to improve Conewago Creek, including:

- Private landowners and farmers
- The Dauphin County Conservation District
- The Manada Conservancy
- Penn State University Agriculture & Environment Center
- The Conewago Creek Initiative
- The Tri-County Conewago Creek Association

After the initial survey and assessment funded by the NFWF grant, the next step of the Conewago Creek Restoration project will be to obtain Chapter 102 and 105 permits from DEP, to ensure the process will protect and maintain the natural resources of Pennsylvania. Once the permits are approved, the project will begin construction, which is currently on track to begin in the Spring of 2021.

The Conewago Creek Restoration project is the first of its kind in Pennsylvania, and has the potential to make Londonderry a well-recognized environmental leader regionally. In addition to greatly enhanced local water quality and reduced flood risk, this project has the potential to positively impact the community by adding a community park, loop into the Conewago rail trail system and serve as a restored area to reintroduce native animals and fish populations.

OLSDS (On Lot Sewage Disposal System) UPDATE SPRING 2020 SEWER DISTRICT NO. 3 JUNE 1, 2019 — JUNE 30, 2020

The Township's OLSDS (On Lot Sewage Disposal System) pumping and reporting Management Program was initiated in 2014 and established districts that requires all properties within each of those districts to have their septic system pumped and inspected once every four years. Every septic system in the Township (including the island properties) and every treatment tank or cesspool associated with every OLSDS shall be pumped and inspected once every four (4) years by a certified pumper/hauler within a specific time frame.

In 2018 the Township began the SECOND CYCLE of the program.

The Township established five (5) pumping districts identified as Sewer Districts 1, 2 and 3 and On-Lot Management Districts B and A. As a reminder the following pumping/inspection schedule is shown below.

For the current pumping cycle, **Sewer District No. 3, which began on June 1, 2019 and runs through June 30, 2020**, it must be pointed out that any pumper/hauler report received by the Township dated **AFTER** June 30, 2020 will be in VIOLATION of the OLSDS Ordinance and citations will be issued for noncompliance. **Please remember that this is a requirement mandated by the DEP and required by state law.**



SOME IMPORTANT FACTS TO REMEMBER:

Before bringing the animals to the Humane Society, residents must first obtain a trap and release voucher OR an animal surrender form from the Township office between the hours of 8:30 a.m. to 5:00 p.m., Monday through Friday. Proof of residency is required. Animals are not permitted inside the Township office.

<u>Trap and Release Vouchers</u>—The trap and release vouchers are for feral (wild) cats only. The animal must be placed in a crate prior to obtaining a voucher from the Township office. One voucher per animal is given. The resident must make an appointment with the Humane Society to have the animal spayed or neutered. The animals will then be returned to the resident so that the resident can release the animal in the original location where it was found.

<u>Animal Surrender Forms</u>—The animal surrender form is for stray cats and dogs. Residents can obtain an animal surrender form at the Township office once the animal has been placed in a crate. One form per animal is given. No appointment is needed to surrender stray animals at the Humane Society.

Dog Licenses—applications are NOT available at the Township office. Residents may purchase a license online at PADogLicense.com. A metal tag will be mailed within a few days. Dogs over three months must be licensed by state law. If not, fines are up to \$300 for each violation. Fees collected are used to underwrite costs of monitoring PA kennels and puppy mills as well as other dog welfare initiatives not funded by tax dollars. Dog tags run with the calendar year and must be renewed annually!

Meals on Wheels

Do you know anyone over age 60 who is home bound because of physical, mental, or emotional disability and is without a caregiver who is able to provide meals on a regular basis? If so, the Dauphin County Area Agency on Aging can help by providing a well-balanced hot meal for delivery to residents of Dauphin County. Meal recipients are assessed by the Agency's Care Management Unit to determine their eligibility. Meals are delivered five days a week by volunteers who observe the well-being of the home bound individual receiving the meal. The volunteers are recruited by our local "Meals-on-Wheels" organization. Recipients are encouraged to make a voluntary contribution toward the cost of the meals according to their financial ability. REMINDER

ON-LOT SEWAGE DISPOSAL SYSTEM INSPECTION PROGRAM (OLSDS)

ON-LOT MANAGEMENT DISTRICT B JUNE 1, 2020 — JUNE 30, 2021

Londonderry Township has been mandated by the Pennsylvania Department of Environmental Protection to establish an On-Lot Sewage Disposal System Inspection Program (OLSDS). Every OLSDS in the Township is required to be inspected and every treatment tank or cesspool associated with every OLSDS shall be pumped and inspected at a minimum regular interval of once every four (4) years by a certified pumper/hauler.

Property owners within On-Lot Management District B are once again required to have their on-lot sewage disposal systems pumped and inspected by a certified pumper/hauler

BEGINNING on or after June 1, 2020 and completed BEFORE June 30, 2021
