OLSDS (On-Lot Sewage Disposal System)

The Township's OLSDS (On-Lot Sewage Disposal System) pumping and reporting management program was initiated in 2014 and established districts that requires all properties within each of those districts to have their septic system pumped and inspected once every four years.

Every septic system in the Township and every treatment tank or cesspool associated with every OLSDS shall be pumped and inspected once every four (4) years by a certified pumper/hauler within a specific time frame.

The Township established five (5) pumping districts identified as Sewer Districts 1, 2 and 3 and On-Lot Management Districts A and B. As a reminder the following pumping/inspection schedule is shown below:

PROPERTY DISTRICT	PUMPING & INSPECTION DEADLINE DATES
Sewer District #1 & #2	June 1, 2022 – June 30, 2023
Sewer District #3	June 1, 2023 – June 30, 2024
On-Lot Management District B	June 1, 2024 – June 30, 2025
On-Lot Management District A	June 1, 2025 – June 30, 2026

Emergency Services

EMA Team Development

Again we are headed into spring. Typically along with spring arriving we see some extreme weather which may include heavy rain, high winds and power outages. We are asking for you to be as safe and prepared as possible. Most of all have a plan and make sure family and friends know what it is. If an emergency arises and help is needed call 911. For non-emergency information you may contact Londonderry Township Emergency Management at 717-564-0678.

Natural disasters, disease outbreaks, and emergencies can have widespread and even long-lasting impacts on supplies, services, and the public health and health care systems. Don't wait for an emergency to happen to prepare. Use the time before and between events to gather essential supplies, learn self-help skills, and build the self-confidence you need to respond quickly and constructively in a crisis. When services and supplies are limited, it is important to have the personal needs, prescriptions, paperwork, power sources, and practical skills you need to respond, such as:

- Talk to your doctor or pharmacist about how you can create an emergency supply of medicines.
- Keep a list of your prescription medicines as well as a current insurance card and medical records. Include information about your diagnosis, dosage, frequency, medical supply needs, and allergies.
- Have nonprescription drugs on hand, such as pain and fever relievers, antihistamines, and antidiarrheal medicines.
- Have ready a cooler and chemical ice packs to chill medicines that need to be refrigerated.
- Wash your hands. Handwashing is one of the best ways to

protect yourself, your family, and others from getting sick.

- Learn how to use a portable generator safely to prevent carbon monoxide poisoning.
- Learn how to create and store an emergency water supply.

Drinking Water: If you don't have safe drinking water, boiling is the surest method to kill disease-causing germs, including viruses, bacteria, and parasites.

You can improve the flat taste of boiled water by pouring it from one container to another and then allowing it to stand for several hours, or by adding a pinch of salt for each quart or liter of boiled water.

Power Sources: On average, people experience about four hours of power loss each year. Power outages caused by a large-scale disaster can last much longer and as a result can become life threatening for people who rely on electrically powered medical equipment and devices. Be prepared for a prolonged blackout with alternative heating and lighting, and backup power sources for your cellphone, appliances, and medical devices.

If you have some extra time to spare we are always looking for volunteers.

We have also signed a contract to replace one of our engines, which is due to arrive in 2024. One other project to note is the upgrade and replacement of some aging HVAC and Plumbing equipment. We mention these projects to give you a heads up that the annual Fire Company Fund Drive Letter will be hitting your mailboxes in the May/June time frame.

In closing I ask that you keep in mind that we are all volunteers committing time to keep all of the residents of Londonderry Township safe.



Fire Company Update

The Londonderry Fire Company at the December 29, 2022, Board of Directors Meeting voted to discontinue Basic Life Support Ambulance service effective June 30, 2023. This decision was not an easy one to make but with the continued attempts of recruiting and retaining volunteers to staff the ambulance we had to do what was right for the residents. What does this mean for you the resident? The current folks that have elected for membership, it will be honored until June 30, 2023. The Fire Company along with the Township is working to find an organization that is willing to provide Basic Life Support services to the Township. Once an organization is found we will have that organization contact the residents.

Road Work Update

Winter is over. Birds are chirping, flowers are blooming and lawn mowers are getting ready to keep lawns manicured once again.

We have many road projects planned in Londonderry Township this year. We have a small crew and occasionally we will close a road and set up a detour to complete a project. Please check the Township website www.londonderrypa.org or the Township Facebook page for upcoming road projects. We will also post the road that will be closed.

We will be closing Foxianna Road from Krepps Road to E. Harrisburg Pike starting Wednesday, May 10th. This project will involve removing approximately 250 feet of roadway, removing the existing storm pipe concrete work, setting a 30 foot long x 10 foot wide x 4 ½ foot arch pipe, raising the road grade by approximately 3 feet, paving and guiderail installation. This project is projected to be completed by June 23rd. Detour will be S. Geyers Church Road to E. Harrisburg Pike.

There will be roadwork continuing on the Rte. 230 corridor this summer along with some of the back roads. Please pay attention to signs and watch for road workers.

BE AWARE OF DIRTY DIRT!!!

DEP wants to help residents and contractors in Pennsylvania ensure they do not accept or use fill materials that may cause contamination. Fill materials are used to bring sites to desirable grades to enhance the usefulness of the properties. Homeowners and contractors need to be aware that there are some "fill" materials out there that can cause potential environmental and/or health concerns, as well as open up property owners to potential liabilities. Here are a few tips to ensure you are using acceptable fill materials on your property

Do your homework...

- Before you buy or accept "FREE" dirt, make sure it is clean.
- Know the **source** of the fill, especially if it is offered to you for FREE.
- Know the supplier and hauler. Check for references.
- Ask for documentation from the provider regarding the source:
 - A bill of lading if you purchased it.
 - An official **DEP FP-001** form that identifies where the fill came from and any testing that was done.
- Do not accept any free material without documentation.

Take a look...or smell...

- If the fill has a petroleum/oil-like or garbage odor...**BEWARE!**
- If the fill has materials such as: plastic, ash, demolition debris such as wallboard, shingles, nails, wood or paint chips...**BEWARE!**
- If the fill appears to be "discolored" or stained...**BEWARE!**
- If you don't know the source of the fill...**BEWARE!**

Get some advice...

- The DEP wants residents and contractors in Pennsylvania to make sure they do not accept or use fill materials that may contain or cause contamination.
- Check with your regional office if you have questions, consult with your local Bureau of Waste Management or DEP office.
- If you don't know the source of the fill...**BEWARE!**

LONDONDERRY TOWNSHIP ILLICIT DISCHARGE AWARENESS

An illicit discharge is any discharge not composed entirely of stormwater, entering a Municipal Separate Storm Sewer System aka an "MS4" aka a storm drain.

An illicit discharge also includes any piping or drainage leading directly into a storm drain that was not initially placed during construction. MS4's are only intended to carry stormwater directly to streams and rivers. Any illicit discharges flowing into an MS4 can pollute the streams in the area, harming the wildlife and way of life of the people who use these streams.

How You Can Help?

The easiest way you can help is by disposing of liquid wastes properly and not allowing them to flow into storm drains. You can also check your storm drains near your home to make sure no pipes are flowing from your home which you were not previously aware of.

Examples of Illicit Discharges

- Sanitary Wastewater
- Septic Tank Effluent
- Chlorinated Pool Discharge
- Improper Oil/Radiator Flushing Disposal
- Laundry Wastewaters
- Spills from roadway accidents
- Improper disposal of household toxins



Exemptions

- Discharges from fire-fighting activities
- Fire hydrant flushing
- Potable water, including water line flushing
- Uncontaminated condensate from air conditioners, coolers, and other compressors and from the outside storage of refrigerated gases or liquids
- Irrigation drainage
- Landscape watering provided all pesticides, herbicides, and fertilizer have been applied in accordance with the approved labeling
- Pavement wash waters where no detergents are used and no spills or leaks of toxic or hazardous materials have occurred
- Routine external building washdown that does not use detergents
- Uncontaminated ground water or spring water

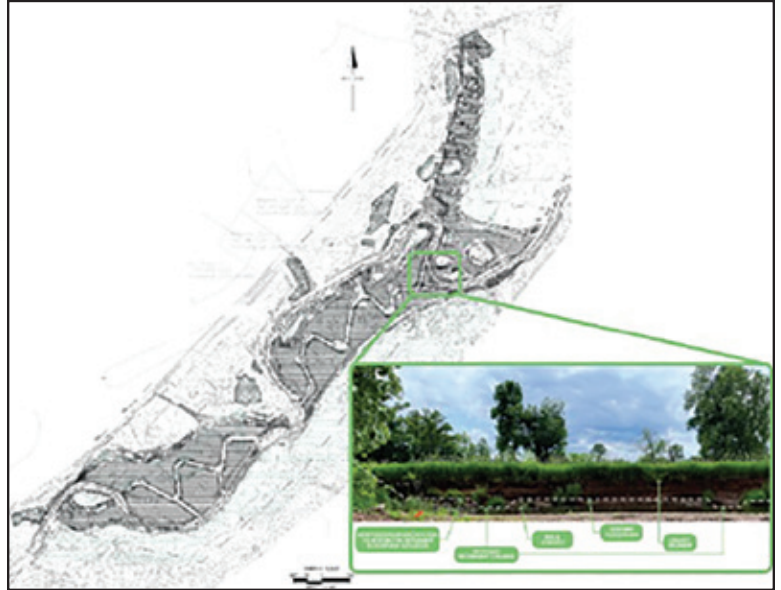

Conewago Creek Restoration

If you have walked on the Conewago Recreation trail recently, you probably notice the creek is "under construction". Londonderry Township has partnered with neighboring communities to fulfill the Municipal Separate Storm Sewer System's Pollutant Reduction Plan. This project is designed to mitigate downstream flooding, remove sediment and nutrients from our waterway, and create wildlife habitat. The major construction of all planned phases is now complete, and we are looking forward to enhancing the project with native plants in Spring 2023

"WEED BE GONE" Recipe

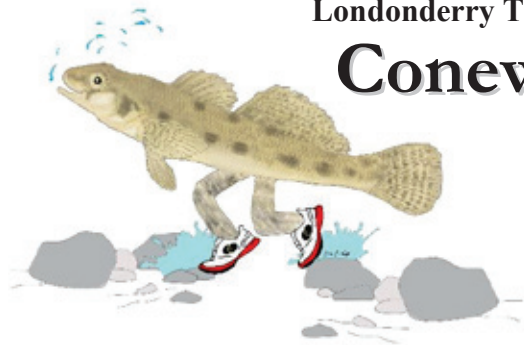
- 1 gallon white vinegar

Grass on the Roads

When mowing your lawn this Summer, make sure you keep all grass clippings and garden trimmings off the road. When left on our roads, they can create dangerous driving conditions, especially for motorcyclists, as well as add to stormwater runoff. This debris, often times containing fertilizer, is not meant to be in our waterways and disrupts the natural ecosystem. Please make sure to either blow your clippings or sweep them from the road. **DO NOT DUMP DOWN THE STORM SEWER.** *It is also a good idea to leave the clippings on your lawn, they serve as a great natural fertilizer!*

Stormwater & Environmental Department

Dauphin County's Water Resource Enhancement Program (WREP) Would Cut Municipal Costs, Improve Water Quality

In recent years, Dauphin County's municipalities have been facing an increasing range of stormwater management, water quality, and flooding issues. Costs for addressing these issues are rising due to the increasing complexity of the impacts and environmental regulations associated with stormwater management.

To address this issue, Tri-County Regional Planning Commission (TCRPC) has been working with the county to create a regional Water Resource Enhancement Program (WREP) that would provide a central framework, offer strategic partnerships and coordinate efforts between municipalities, thereby cutting municipal costs by up to 90 percent.

In addition to saving taxpayer dollars, this voluntary program will save considerable time and effort for participating municipalities by enabling them to participate in regionalized services where it makes the most sense to do so.

It's important to note that this program is meant to enhance -- not replicate or replace -- existing stormwater management programs, and would not create new fees. The overall savings, however, would rely on participation: The more municipalities involved, the more they will save.

The first project to be undertaken under WREP is the Conewago Creek Restoration Project, a watershed-based approach to fulfill MS4 requirements, reduce local flooding and improve local water quality in Londonderry Township. The MS4 benefits for sediment reduction are able to be shared with other municipalities in the watershed (Highspire, Middletown and Steelton boroughs and Lower Swatara and Swatara townships) at a very cost-effective rate thanks to the efforts of Londonderry Township in securing grant funding and Dauphin County's contribution through a recently awarded grant from the PA Department of Environmental Protection.

Participants are able to buy into this project through WREP at savings ranging between 60 and 90 percent, compared to previous projects proposed individually. Beyond the cost savings, all residents will benefit from better flood prevention and improved water quality for the region's streams and groundwater. The Dauphin County Board of Commissioners are supportive of this program due to its many benefits and potential for cost savings, especially as more municipalities sign on.

There will be an extensive outreach effort over the next few months to provide information and answer questions about WREP.

Tree Canopies

Although tree canopies are scenic and enjoyable to drive through, they can also cause a hazard to vehicles and the road surface. While low hanging branches keep the road shaded, they also keep the sun from drying the road after it rains, and hinders the melting process of ice and snow in the winter. Emergency vehicles must travel slower to avoid low hanging branches from striking their vehicles. Delivery trucks, garbage trucks, and school buses also have a difficult time passing safely under low hanging limbs. During rain and snow events, these limbs hang even lower than usual making safe passage more difficult.

It is not our intent to remove all trees from hanging over the roadway. But we do have to make it safe for all vehicles and pedestrians to travel the roadways. We will be removing limbs back 3 to 4 feet from the edge of the pavement, and 16 to 20 feet above the road surface. We will also be removing the dead limbs that we can reach before they cause damage to vehicles or pedestrians.

SOME IMPORTANT FACTS TO REMEMBER:

Before bringing the animals to the Humane Society, residents must first obtain a trap and release voucher OR an animal surrender form by contacting the Township office Monday-Thursday 8:00 a.m. to 4:00 p.m. and Friday 9:00 a.m. to 2:00 p.m. Proof of residency is required. Animals are not permitted inside the Township office.

Trap and Release Vouchers—The trap and release vouchers are for feral (wild) cats only. The animal must be placed in a crate prior to obtaining a voucher from the Township office. One voucher per animal is given. The resident must make an appointment with the Humane Society to have the animal spayed or neutered. The animals will then be returned to the resident so that the resident can release the animal in the original location where it was found.

Animal Surrender Forms—The animal surrender form is for stray cats and dogs. One form per animal is given. No appointment is needed to surrender stray animals at the Humane Society.

Dog Licenses—Residents may purchase a license online at PADogLicense.com. Lifetime licenses are available at the Treasurer's Office at Dauphin County. org.



International Property Maintenance Code 2018

The Board of Supervisors at their August 1, 2022 meeting voted to update the 2009 International Property Maintenance Code ("IPMC") with the 2018 edition of the IPMC with the adoption of Ordinance 2022-01 that may be found on the Londonderry Township web site at www.londonderrypa.org

The IPMC includes in part a variety of requirements for exterior property areas, and exterior elements of the structure by providing:

- specific criteria for regulating the installation and maintenance of building components
- maintenance requirements for the structural, weather resistance, sanitary and safety performance of the structure's exterior.
- criteria for maintaining exterior property areas.

- minimum maintenance requirements for vacant structures and land.
- criteria to determine unsafe structure conditions based on specific parameters.

The provisions of the IPMC, as modified by revisions as provided in Section 5-202, as amended, of Part 2 of Chapter 5 of the Londonderry Township Code of Ordinances, apply to all existing residential and nonresidential structures and properties within the Township, including all island properties, and constitute minimum requirements and standards for premises, structures, equipment and facilities. Copies of the IPMC booklet are on file in, and can be reviewed at, the Township Building in the Office of the Code Enforcement Officer.

Portable Generator Safety Tips

Take precautions for your safety and the safety of those working to restore your power

ALWAYS

- Read and follow all manufacturer's operating instructions
- use your generator outdoors, away from open windows, vents or doors
- Allow the generator engine to cool at least 2 minutes before refueling
- Store the recommended type of fuel for the generator in an approved, properly labeled safety can
- Maintain your generator according to the manufacturer's schedule
- Have a battery-operated carbon monoxide alarm to check for deadly buildup

- Turn off the generator and let it cool before refueling to prevent a fire
- Start or stop the generator ONLY when no electrical loads are connected
- Allow at least 4 feet of clearance on all sides of the generator when it is operating
- Keep children away from generator at all times

NEVER

- Never use a generator inside your home, garage, basement, crawl space or enclosed area, even with ventilation, as carbon monoxide buildup can kill
- Never operate the generator near combustible materials

- Never plug your generator directly into your home outlet as this presents an electrocution risk to utility workers and neighbors served by the same utility transformer - have a qualified electrician install a power transfer switch instead
- Never operate a generator under wet conditions or touch it with wet hands (put it on a level, dry surface under an open, canopy-like structure)
- Never overload the generator or connected appliances and components can be damaged
- Never cut corners when it comes to safety



Need A Building And/Or Zoning Permit? Just Follow The Online Application & Payment Process

Building and zoning permit applications and payments are now made online. **Payment can also be made by check or money order (made payable to Londonderry Township) at the township building by placing payment in the drop box located inside the lobby or by mailing payment to Londonderry Township at 783 S. Geysers Church Road, Middletown, PA 17057. Cash is not accepted.** Pickup times for permits must be arranged with the Codes Officer **OR** your permit will be mailed, once confirmation of payment has been made.

Pennsylvania Homeowner Assistance Fund 888-987-2423 • <https://pahaf.org>

Established through the 2021 American Rescue Plan, the Commonwealth of Pennsylvania was awarded \$350 million in COVID-19 relief funds for homeowners. The Pennsylvania Homeowner Assistance Fund (PAHAF) provides financial assistance to address mortgage delinquencies and avoid default, displacement and foreclosure for eligible Pennsylvania homeowners experiencing financial difficulties due to the coronavirus pandemic. PAHAF provides assistance of up to \$50,000 per homeowner for the following mortgage and housing-related expenses:

- **Mortgage Reinstatement:** Funds to bring a first mortgage current and to pay other housing-related costs, such as taxes and insurance, if included in the mortgage payment.
- **Forward Mortgage Payment:** Forward payment assistance for up to 6 months or up to program cap.
- **Property Charges:** Funds for past due property taxes, homeowner association (HOA) fees, condominium fees or common charges that put ownership of the property at risk.

- **Utility Payment:** Funds to resolve delinquent payments for utility services including: electric, heating fuel, water, trash and/or sewer bills; particularly if no other assistance program currently exists, and that there is imminent loss of utility disconnection, liens, possible foreclosure, or homeowner displacement. A one-time fill-up for the expenses related to pre-paid fuel delivery may be provided.

Applicants must be at least 30 days past due/delinquent on payments for all assistance types, except forward mortgage and pre-paid fuel delivery, in order to qualify for PA assistance. Applicants who are eligible will meet the following criteria:

- Household income is equal to or less than 150% area median income (AMI), which varies by locality. Note: PAHAF Program priority will be given to households at or below 100% AMI.
- Homeowner owns and occupies the property as their primary residence.
- Property is in Pennsylvania.

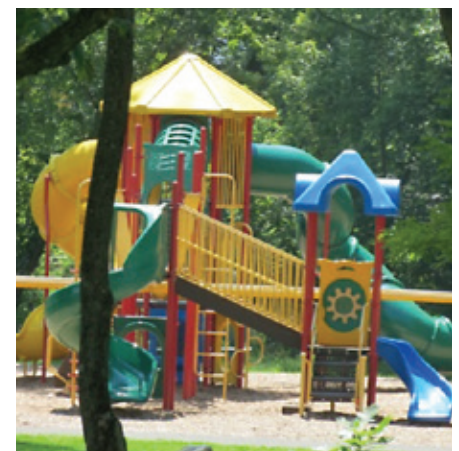
Sunset Park Pavilion Rental

Londonderry Lionettes

The Londonderry Lionettes continue caring and sharing in our community, surrounding communities, and statewide. Meetings are held at the Londonderry Firehouse at 1:00 p.m. on the first Wednesday of February thru May, and September thru November. Special activities are held in June and December. Projects for 2023 include:

- Make valentines for the Alzheimer's unit and adopted grandmothers at Oak Hill Retirement Village, as well as, for Londonderry's Meals on Wheels clients.
- Provide healthy snack bags for Meals on Wheels clients and adopted grandmothers at Oak Hill Village Retirement Home.
- Provide Easter bags for residents at Merakey, a non-profit organization which provides a home and a full range of services to individuals with all levels of disability.
- Collect used eyeglasses (see separate article) for the Pennsylvania Lions Club. To date, the Lionettes have collected 2,366 pairs of eyeglasses since the project began eight years ago. They also collect aluminum can and soup tabs for the Ronald McDonald House. Both of these are ongoing projects.

Meals on Wheels

Are you over age 60, home bound because of physical, mental, or emotional disability and without a caregiver who is able to provide meals on a regular basis? If so, the Dauphin County Area Agency on Aging can help by providing a well-balanced hot lunch meal for delivery to residents of Dauphin County who have been determined to be eligible for the program by the Agency's Care Management Unit.

Lunch meals are delivered five days a week (Monday through Friday) by volunteers who observe, in the brief contact, the well being of the homebound individual receiving the meal. Volunteers are recruited by community Meals on Wheels volunteer groups.

Londonderry Lionettes

CHANGE LIVES, ONE PAIR AT A TIME & HELP THE RONALD McDONALD HOUSE

The Londonderry Lionettes are collecting used eyeglasses and tabs (from beverage and other **aluminum** cans). NOTE: If the tab does not stick to a magnet, it's aluminum. The eyeglasses go to a local Lions Club who forwards them to the Lions Eyeglass Recycling Center where they are cleaned, sorted by prescription strength, and packaged. Recycled glasses are distributed to people in need in low and middle-income communities where they will have the greatest impact. The can tabs go to the Ronald McDonald House (RMHC) in Hershey which sells the tabs to a local recycling company. Funds generated help support their programs.

Collection boxes for eyeglasses only have been placed at Karns, Londonderry Elementary School, Evangelical

U.M. Church, St. Peters Lutheran Church, Presbyterian Church, Church of God, Geyers U.M. Church, and New Beginnings Church. Collection boxes for eyeglasses and can tabs can be found at the Londonderry Township building, Street Stores Wholesale Hardware, and St. Paul Evangelical Lutheran Church in Hummelstown.

Other sites are being sought as well. If you would like to have a collection container in your workplace, church or business to help support either of these programs, please contact: Anita Housman at 756-7467 or Louise Morgan at 944-6518. Please place all eyeglass and can tabs separate in a plastic Ziploc bag for protection during transport. NOTE: The Lions Club only accepts eyeglasses, no sunglasses, eyeglass cases, or loose lenses.

V.I.P. Senior Van Service

The V.I.P. is a van service for seniors 65 + over who are residents of Londonderry Township. The van provides transportation to and from doctor and hospital appointments as a priority. If available, other locations within Dauphin County for necessities (i.e. grocery store, bank) may be scheduled. The van is not handicapped accessible so residents must be able to get in and out of the van without assistance. There is no charge for this service, however, donations are strongly suggested and appreciated to help with the costs for gas and upkeep of the van. To date for 2021, we have provided over 50 rides for seniors. This is a much needed and appreciated service for Londonderry Township residents.

PLEASE NOTE: this van service is only possible through the efforts of volunteers. We are in **desperate** need of volunteers to take phone requests and call drivers. This can be done from one's own home and in one's own time frame! We are also in need of volunteers to drive the van. You only need a valid driver's license and a clean driving record. Driving is on a "can do/if available" basis as the need arises.

Both of these volunteer opportunities can fit anyone's schedule.

COME ON SPRING!

You should have received the County/Municipal Real Estate tax bill by now. They were mailed February 1. If you did not receive your tax bill, please call me.

Please make sure you have filed a "Homestead Exclusion" application. This is the money from the casinos that is allocated back to the school district. This reduces the assessment by the same amount for all properties that have qualified for the exemption. It is for primary residences only. Typically it has reduced the School Real Estate tax by a little more than \$200.00.

If you have not filed for the exemption, you must file by March 1 for the following year. This reduces the School Real Estate tax, it does not affect the County/Municipal tax sent out in February.

If you have already qualified for the exemption and nothing has changed as far as it being your primary residence, you do not need to do anything. Dauphin County sends out a notice every 3 years, but if nothing has changed you do not need to respond.

If you're not sure if you are getting the reduction please call me and I'll look it up for you.

The school personal occupation tax bills are mailed in July with the school real estate tax bills. They are not included with the County/Municipal tax bills mailed in February. Payments can be dropped into the mail slot at my office. Please **do not** bring payments to the Township office.
