The Londonderry Fire Company continues to provide 100% volunteer fire and rescue services to the citizens of Londonderry Township, therefore using no tax dollars to supplement wages and benefits of our members. So, what do the fire tax dollars that property owners pay get used for? Those funds are used to pay our everyday expenses, vehicle maintenance costs, vehicle fuel costs, building maintenance costs and any other expenses that are needed to be paid. As you can tell the fire tax dollars do not cover all of those costs which leads us to doing fundraising events such as Lenten Fish Fry, bingo and an annual golf outing.

We mention all of these items so that you can be on the lookout for the Annual Fire Company Fund Drive which will be sent out in the coming months. We ask that you





try and contribute as much as you financially can so that there isn't a need to raise taxes.

Enough of the financial side of things and on to the personnel side of things. We continue to struggle with attracting new members and our current members continue to age. We are in need of individuals that are 14 years of age or older and willing to learn and train to become a fireman and serve the community as a volunteer, maybe even consider making it a career. No prior experience is necessary, we will provide and pay for all entry level training and any continued training that is required. We not only are looking for firefighters but also fire police officers and those individuals that are willing to assist in fundraising, public events and any administrative functions. Here are some things that have been completed since that last publication. The HVAC system upgrades have been completed (\$280,000.00) and has been completely paid. We obtained a Regional Fire Fighting Grant (\$630,000.00) along with Middletown, Hummelstown and Highspire to replace self-contained breathing apparatus. We continue to work with folks on obtaining sewage and water at the fire company. The



Fire Company continues to wait on the production and arrival of Engine 54-1 (\$829,989.00), for which we have received a grant from the Dauphin County Gaming Board in the amount of \$150,000.00. We are also applying for another Regional Fire Grant along with Middletown, Hummelstown, Highspire and Lower Swatara Township to replace and upgrade our radio equipment.

In closing I cannot stress enough the importance of the members of the community who continue to commit countless hours to keeping our community safe. If you have ever considered or thought about joining, please reach out to us or stop by to take a look around. Without YOU we cannot continue to remain volunteer and keep YOU safe at little to no cost. Also, we cannot continue to be efficient without your continued support, it does not go unnoticed.

OLSDS Update (On-Lot Sewage Disposal System)

The Township's OLSDS (On-Lot Sewage Disposal System) pumping and reporting management program was initiated in 2014 and established districts that requires all properties within each of those districts to have their septic system pumped and inspected once every four years.

Every septic system in the Township and every treatment tank or cesspool associated with every OLSDS shall be pumped and inspected once every four (4) years by a certified pumper/hauler within a specific time frame.

The Township established five (5) pumping districts identified as Sewer Districts 1, 2 and 3 and On-Lot Management Districts A and B. As a reminder the following pumping/inspection schedule is shown to the right:

Codes/Zoning

Need A Building And/Or Zoning Permit?

Just Follow The Online Application & Payment Process

Building and zoning permit applications are now available online, visit www.londonderrypa.org/buildings-zoning.php for more information!

Permits will be invoiced upon completion of review, fees may be paid online or at the Township Office upon permit pick up. Londonderry Township does NOT accept cash or credit card at the Township Office, check or money order only. All permits must be picked up at the Township Office. If you would like to pay a permit fee online, please contact the Township Codes Office.

Differences Between Permit Types

Londonderry Township requires permits for many types of construction and other work performed at residential properties within the Township. "Zoning Permits" and "Building Permits" have separate requirements and forms that need to be filled out. There are potentially other permits that may be required as well such as Stormwater Permits, Floodplain Permits, and other required permits and reviews depending on the scope of the project. Permits have varying review and approval times depending on the scope of the project, completeness of the application submitted, volume of permits currently under review, and requirements under State law.

Examples of work needing a "Zoning Permit"

Installing or changing the area of a fence.

- Installing or construction of accessory buildings/structure, including sheds, carports, etc.
- Installing or construction of decks, porches, or patios.
- Installing or construction of any paved surface, including walkways, driveways, or private drives.
- A zoning permit is required for any "use" and/or installation or construction for that use.
 A "Permitted Use" under the zoning ordinance still requires an application to be submitted and a permit to be issued.

Examples of work needing a "Building Permit"

- Building an addition onto your house, including attached garages and attached carports.
- Swimming Pools -Any pool, including "seasonal" portable and "wall-less" pools, capable of holding 24 inches or more of water.
- Changing the size of doors and/or windows.
- Alterations that include the moving of walls, electrical wiring, plumbing piping, HVAC components and ducting, and LP or Natural gas piping.
- Replacement of Electrical Panels, HVAC systems, and other such major component replacements that would not be considered an "ordinary repair".

Examples of work NOT needing permits

- Replacing siding.
- Replacing floorboards on decks or porches.
- Replacing windows and doors IN THE SAME SIZE OPENING.
- Painting, carpet, tiling, cabinetry (kitchen cabinets or bathroom medicine cabinet).
- Replacing fixtures, such as toilets, faucets, lights, ceiling fans, etc., as long as the fixture is not being relocated.

Driveway Permits

All new driveways require a permit before installation. Most driveway repairs and/or replacements require a Driveway Repair Permit. If you are planning to do any repairs to your driveway, but are unsure if a permit is required, please contact the Township Zoning Officer at 717-944-1803 or email dbrady@londonderrypa.org.



Stormwater & Environmental Department

LONDONDERRY TOWNSHIP ILLICIT DISCHARGE AWARENESS

An illicit discharge is any discharge not composed entirely of stormwater, entering a Municipal Separate Storm Sewer System aka an "MS4" aka a storm drain.

An illicit discharge also includes any piping or drainage leading directly into a storm drain that was not initially placed during construction. MS4's are only intended to carry stormwater directly to streams and rivers. Any illicit discharges flowing into an MS4 can pollute the streams in the area, harming the wildlife and way of life of the people who use these streams.

How You Can Help?

The easiest way you can help is by disposing of liquid wastes properly and not allowing them to flow into storm drains. You can also check your storm drains near your home to make sure no pipes are flowing from your home which you were not previously aware of.

Examples of Illicit Discharges

- Sanitary Wastewater
- Septic Tank Effluent
- Chlorinated Pool Discharge
- Improper Oil/Radiator Flushing Disposal
- Laundry Wastewaters
- Spills from roadway accidents
- Improper disposal of household toxins

Exemptions

- Discharges from fire-fighting activities
- Fire hydrant flushing
- Potable water, including water line flushing
- Uncontaminated condensate from air conditioners, coolers, and other compressors and from the outside storage of refrigerated gases or liquids
- Irrigation drainage
- Landscape watering provided all pesticides, herbicides, and fertilizer have been applied in accordance with the approved labeling
- Pavement wash waters where no detergents are used and no spills or leaks of toxic or hazardous materials have occurred
- Routine external building washdown that does not use detergents
- Uncontaminated ground water or spring water

Hopefully spring has sprung or is just around the corner!

You should have received your Dauphin County/ Londonderry Township Real Estate tax bill by now. They were mailed February 1st. If you haven't received it please call me. The discount period ends March 31st. Payments must be in my office or postmarked by March 31st to qualify for the 2% discount. The Personal Occupation Tax bill is mailed with the School District Real Estate bill July 1st, not with the County/ Township Real Estate (spring) taxes.

TAX REBATES

The Rent/Rebate program has been expanded this year! The income level has been raised to \$45,000 from \$35,000. The income for renters has been raised to \$45,000 from \$15,000. The maximum rebate has been raised to \$1,000 from \$650.

The program benefits income eligible Pennsylvanians age 65 and older, widows and widowers age 50 and older, and persons with disabilities 18 and older.

In short, if you're in one of these age groups and your income is under \$45,000, you may get a rebate check from the State for between \$380 and \$1,000. The application deadline is June 30, 2024 for the 2023 rebate. Forms and instructions are available

from the PA Department of Revenue website. I do have some forms in my office.
