Mr. Henninger will be drawing up a hold harmless form for the State Police to sign prior to using the homes.

Planning Commission Vacancy

Mr. Foreman was directed to contact the two applicants and arrange interviews for January 15, 2008 with the Board of Supervisors.

Mobile Home Park Inspections

Mr. Foreman informed the Board of his inspection findings of Pine Manor MHP & Cedar Manor MHP on December 17, 2007 and January 2 & 6, 2008. Mr. Foreman stated that GSP Management, owner of both Mobile Home Parks, has been cooperative and has begun to make repairs. Mr. Foreman is working on a

report that will inform GSP Mgmt. of his findings and a reasonable time frame to get the work done.

Scott Houser, 30 Rose Ave., asked for specifics on when the work will be completed and if fines will be imposed on GSP Mgmt.

Mr. Henninger stated that these issues are very important to the Township and Mr. Foreman is handling the situation properly and fairly, but it will take time.

EMA – Sam Naples

Mr. Naples informed the Board that he will be attending Pandemic Training on January 17, 2008 at Dauphin County EMA.

Mr. Naples reported that in 2007 they had no flooding or major catastrophes and that the EMA volunteers had logged 103 hours of training and 105 hours of meetings.

Public Works – John Kesler

Mr. Kesler reported that the trucks are ready for winter weather and material is on hand if needed.

7. New Business

Judy Vaughn, 22 Rose Avenue – Ms. Vaughn is new to the Township and will be constructing a new home which she would like to use solar panels for energy. She asked general questions regarding permitting and if solar energy is used elsewhere in Londonderry Township.
