**Approval of Minutes – September 8, 2009 and October 20, 2009**

Andy Doherty made the motion to approve the September 8, 2009 and October 20, 2009 minutes as presented, seconded by Anna Dale, motion carried.

**1. Managers Report – Steve Letavic**

**Check Presentation** - The Board of Supervisors presented a check in the amount of \$6000.00 to the Lebanon Veterans Administration Hospital from funds raised at the July 4, 2009 celebration held in Sunset Park.

**Budget Update** – Bill Kametz made the motion to hang the budget for 30 days and advertise that the budget is available for review, seconded by Andy Doherty, motion carried.

**Sunset Stream Restoration** – Steve Letavic informed the Board that the stream restoration project has been completed and stabilized. Signage will be installed in the future.

**2. Treasurer's Report - Deana Corrigan requested the board's approval of payment of invoices from the General Fund, Golf Course, Escrow Account, and Liquid Fuels Fund in the following amounts:**

**Zoning Hearing Board** – Steve Letavic informed the board that at the October 12, 2009 Zoning Hearing Jim Foreman's interpretation was upheld and the garage built on Beech Island, Parcel #34-027-025-041, was built in a floodway without a permit and must be removed from the floodway. The applicant has 30 days to appeal.
