# Golf Course Manager – Mike Johnson Golf Course Meeting notes for August & September 2013

- Total gross revenues for the month of August were: \$166,569.86 compared to \$144,972.94 in 2012.Total gross revenues YTD are \$755,467.47 compared to \$773.999.01 in 2012.
  - (we are -\$ 18,531.54 behind last years totals do to weather related issues, so far we have been closed 41 more days this year compared to last year at this time!)
- We are continuing to market our Golf Tee Sponsorship Program to any business or individual that would like to advertise with us on our golf course tee signs as well as in our clubhouse.
- We held our 7<sup>th</sup> Annual TMI Golf Outing on Friday August 9<sup>th</sup>
  - TMI presented a check for \$50,000 to the Londonderry Township Fire Company.
  - This brings the total contribution, for the seven years of this tournament, to \$435,000.00
- We have the clubhouse rented out 6 times in September for private events.
- For the month of September we will continue to send out all of our information regarding golf outings, clubhouse rentals, memberships as well as other specials to our past outings, clubhouse guests and golfers that have played our course.
- We have 10 golf outings booked in September
- For 2014 so far we have 65 golf outings booked for the season, as well as the clubhouse being rented out an additional 14 times for private events.
