# Approval of Minutes - April 20, 2009 and May 18, 2009

Mr. Alwine motioned to approve the April 20, 2009 minutes as presented, Mr. Grossman seconded. Motion approved.

#### **Creek Side Meadows Sub-Division**

Joel McNaughton presented the plan with accompanying waivers for curbs and sidewalks and cart way widths. Carolyn Akers had concerns relative to storm water on her property and financial responsibility for sidewalks. The developer agreed to install a pipe to carry storm water from the top of Carolyn's driveway onto the developers' site to alleviate existing storm water issues. Much discussion centered around a deed notation that Carolyn believed absolved her from financial responsibilities for sidewalks. Peter Henninger, Township Solicitor indicated that Carolyn needed to seek private counsel relative to that matter, and that as long as he was counsel he would ensure that the Township never pays for sidewalks.

The developer agreed to over lay London Avenue (1.5" overlay) in its entirety in exchange for the granting of waivers of curbs and sidewalks and cart way width. This proposal was supported by Andrew Kenworthy, Township Engineer, John Kesler Public Works Director and Jim Foremen, Zoning and Codes Officer.

Mr. Ames motioned to recommend to the Board of Supervisors a waiver for curbs, Mrs. Basehore seconded. Motion approved.

Mr. Alwine motioned to recommend to the Board of Supervisors to approve the plan, Mr. Ames seconded. Motion approved.
