Amendment of Minutes – September 17, 2007

Mrs. Basehore motioned to accept the minutes as presented, Mr. Alwine seconded. Motion approved.

Karanja Subdivision

Andy Loraw of Fishbach-Morgan Engineers requested waivers to several ordinance requirements and also requested a recommendation of approval of the plan to the Board of Supervisors.

Mrs. Basehore motioned to recommend to the Board of Supervisors approval of the waiver for all existing buildings, etc. to be shown within 100 feet of tract, Mr. Ames seconded. Motion approved.

Mr. Alwine motioned to recommend to the Board of Supervisors approval, conditioned upon receipt of a request for modification of requests regarding illumination standards consistent with discussion with the Planning Commission whereby the developer will be requesting two light poles on Lot #1, one on Lot #2 and one on Lot #3 with dusk-to-dawn lighting, the maintenance and illumination requirements to be the responsibility of the lot owners, the Planning Commission moved to recommend the granting of a modification of those requirements set forth in subsection 411 of the Subdivision and Land Development Ordinance, Mrs. Basehore seconded. Motion approved.

Mrs. Basehore motioned to recommend to the Board of Supervisors denial of the waiver request of curbs and gutters along Karannia Way, Mr. Ames seconded. Motion approved.

Mrs. Basehore motioned to recommend to the Board of Supervisors approval of the waiver for curbs and gutters along Foxianna Road where it intersects Lot #1 and Lot #2, Mr. Alwine seconded. Motion approved.

Mr. Ames motioned to recommend a deferral of sidewalks with a note on the plan that they will be provided if, and when, they are ever required by the township, Mrs. Basehore seconded. Motion approved.

Mrs. Basehore motioned to recommend to the Board of Supervisors approval of the waiver that the significant features within 200 feet of the project area be shown on the plan, Mr. Alwine seconded. Motion approved.

Due to the unique circumstances with regards to this plan's submission and approval process to date, and based on the representation of the developers's engineer that he will not present the plan to the Board of Supervisors for approval until all comments of the Township engineer have been addressed and any plan revisions necessary based on the Board of Supervisors' determinations with regards to waiver and modification requests are completed, and with the understanding that the Board of Supervisors may well instruct the Applicant to come back to the Planning Commission prior to consideration of said plan for approval by the Board of Supervisors, Mr. Alwine motioned to recommend approval of the plan subject to the comments and representations above-mentioned, seconded by Mrs. Bashore. Motion approved.
