RESOLUTION OF THE (SUPERVISORS) (COMMISSIONERS) (COUNCILMEN) of LONDONDERRY (TOWNSHIP) (BOROUGH) (CITY), DAUPHIN COUNTY, PENNSYLVANIA (hereinafter "the municipality").
